

THE KATHLEEN C. SPICER SCHOLARSHIP FUND

The Kathleen C. Spicer Scholarship Fund was established in a Trust created under the Will of Kathleen C. Spicer, who practiced law in Cobb County during her lifetime. The Will directs that the income from the trust shall be used to award annual scholarships to deserving students who are **bona fide residents of the City of Marietta or Cobb County, Georgia, for the purpose of awarding them for scholastic attainments and promise** and to enable or assist them to attend accredited colleges, junior colleges and universities. Said funds shall be used for the purpose of enabling or assisting such individuals to pursue courses of study **leading to baccalaureate degrees** and shall not be used for the purpose of enabling or assisting students to obtain post-graduate or professional degrees or training.

The Trustee has the power to award either **partial or full** scholarships in their discretion and scholarships shall be used to pay for tuition, academic fees, books, housing, food, travel and other living expenses incurred by them in connection with pursuing their educational objectives.

No scholarship will be awarded for a period of time greater than one year, although the recipient of any scholarship shall have the right to apply for scholarships for each year in which they are enrolled in an accredited college, junior college or university to obtain a baccalaureate degree.

It is the intention that scholarships shall be granted to one or more graduating high school students in each year as well as to individuals who have previously received scholarships.

Preference shall be given to individuals who have previously received scholarships.

It is Ms. Spicer's purpose in establishing this fund to **encourage, recognize, and award scholarly attainments and excellence**, and charging the Trustee with responsibility of identifying individuals in Marietta and Cobb County, Georgia, **who have shown promise of achievement and who will be encouraged to pursue their academic goals by reason of being named as recipients of the scholarship.**

The Trustee **may** take into consideration the financial needs of the applicants but not be guided solely by the need in granting the scholarship.

Applications must be received no later than April 15th.

All applicants will be notified in writing of the Advisory Committee's decision by July 1st.

Please note that an applicant is eligible for a maximum of four awards.

Awards are made payable to the college or university and will be mailed in early August.
